Zoom meeting called to order by President Dennis Boylan at 7 pm. Quorom report.

Next month marks the one year anniversary of the pandemic; we did not hold a meeting in March of 2020; our first zoom meeting was April 2020.

PMA Update, presentation by Gail Harrity, President of the Philadelphia Museum of Art. Gail talked about the museum's activities over the last year. The museum faced a number of challenges this year with the covid epidemic and the encampment. The Rodin museum remains closed; the main building at PMA is now open. Safety measures are in place. The museum continues to build its art collection. She showed us some beautiful works of art by BIPOC artists through the years. PMA continues to try to address issues of systemic racism in all of their institutions. In 2000 the museum started an African American Art Collection committee. There are two upcoming exhibitions (Senga Nangudi and Emma Amos). There will also be a Jasper Johns exhibition opening this fall. PMA relies on gifts of works of art from collectors. PMA has an enormous positive economic impact on the city and state, attracting visitors from all of the world. The museum collaborates with the city hosting many important events. Gail shared many accomplishments during her tenure. Frank Gehry has been hired to help renovate and expand the building and improve visitor experience. He is going to help address critical infrastructure needs. They have reopened the vaulted walkway (south entrance). Now working on the west entrance to make it ADA accessible. The old auditorium is being replaced with the Forum. They have expanded the American and Contemporary Art Galleries. Future phases include a new auditorium and new loft spaces. There is not yet a date for the reopening of the Rodin. Gail responded to guestions from the attendees via chat. She will be stepping down as president of the museum this spring.

Reinventing MLK drive, presentation by Randy LoBasso of the Bicycle Coalition of Greater Philadelphia. The drive has been closed to motor vehicles throughout the pandemic to allow for recreation and social

distancing. Survey data is very positive. It has gone from a high injury road to a very safe road. Today about 5000 people per weekday use the trail, as opposed to about 500 per day pre-pandemic. Most of these are new trail users. The Bicycle Coalition is proposing two recommendations for MLK:

- 1. Permanently turn MLK into an open street, with no motor vehicles.
- 2. Turn MLK into a separated busway with a physically split road; half dedicated to non-vehicular traffic.

VonColln Memorial Park update. The fencing removal date has not yet been set. Parks and Rec are now saying that fencing will be coming down after remediation of the field.

Cox Park Memorials for Tully and Jane Speaker and Russell Meddin will be installed this spring; Councilwoman Helen Gym will present her resolution in recognition of their contribution to the neighborhood

**Old Business**: The streets department decision to change direction of Cherry Street remains in place; nothing has changed to date. This is an ongoing sensitive issue. Dennis continues to address concerns about trucks delivering to Giant.

**New Business**: There is a new apparatus over the steam vent at Peddler Coffee; Dennis will follow up.

## **ZONING COMMITTEE REPORT**

30 N. 23<sup>rd</sup> Street- Part of the Riverwalk project, Doggie VIP is proposing a 'Doggie Day Care' located in the South Tower of Riverwalk. The proposal for 'Animal Services', is a permitted use, but 'Boarding and Other Services' requires a variance. The Applicant has already presented at a near neighbor meeting and will make an official RCO presentation at the January 12, 2021 Board Meeting. The ZBA hearing is scheduled for April 21, 2021. The Board agreed to "Not-Oppose" the Boarding and other Services variance with the proviso that it be limited to Boarding of cats and dogs and not include Taxidermy, Veterinary, or Crematory Services.
